

Public opinion survey to assess the changes in citizen's awareness of civil society and their activities





Methodology: quantitative survey of Ukrainian population

Sample size 2,097 residents of Ukraine.

Sample design The interviews were conducted with the residents of Ukraine aged 18 years old and older. Sample design corresponds to the distribution of adult population of Ukraine by age, sex, oblast and settlement type according to the data of the State Statistics Service of Ukraine as of January 1, 2018 (excluding AR Crimea and NGCA of Donetsk and Luhansk oblasts).

Method CAPI: face-to-face interviews on tablets at respondent's home

Fieldwork dates July - August, 2020

Margin of error Margin of sample error (not including design effect) does not exceed 2.2% for national sample. It can be different for every response to every question in all surveys. On these slides, the margin of error is shown for each question/option



K is statistically grater than F



Q: Are you engaged in life of your community (house, street, district)?














Q: How would you assess the work of this organization/initiative?




Q: Have you made any donations to charitable or civil society organizations during the past 12 months? Q: If so, have you used the right for tax discount for donations you made during the past 12 months?




Q: Who do you think should mostly finance civil initiatives/NGOs? — multiple response set



Q: What amount would you contribute personally to a cause that you believe in and to an organization or group that you trust?




Q: Have you ever contributed personally to any of the listed initiatives?





Q: If you decided to financially support a certain initiative, which factors would play the most important role in your decision?








Q: Choose the three most important issues for Ukraine today









Countering corruption




Q: In your opinion, who has the biggest role to play in countering corruption in Ukraine? *No* more than 3 answers

Q: In your opinion, to what extent is the government of Ukraine effective in fighting corruption?












Q: Have you or your family members directly faced corruption (bribe, extortion, nepotism, etc.) during the last 12 months?








Q: What legislation contains the formulation of the fundamental rights of Ukrainians?





Q: What are the fundamental rights and freedoms you, as a citizen of Ukraine, possess?











Q: How is local self-government formed?





Q: What is the rate of income tax applied* for individuals in Ukraine, according to the legislation?








