


Compared to the period before Russia's full-scale invasion of February 24, 2022, how often did you? (sum of options "much more often" and "somewhat more often")





Compared to the pre-war time, how often do you help others?









Awareness and Perception of the Work of CSOs How would you assess your awareness of the work of Ukrainian civil society organizations? - *Aware*






Overall, how would you assess the work of Ukrainian civil society organizations?











Awareness and Trust to Informal Civic Initiatives How would you assess your awareness of the activities of informal citizen-led initiatives? - *Aware*






Overall, how would you assess the activities of informal citizen-led initiatives? *(respondents aware of the activities of informal citizen-led initiatives)*








Gender differences in perceptions of informal initiatives and CSOs

Do you believe that giving bribes, unofficial services, or gifts, or using personal connections can be justified if it solves an important problem for you?











Have you ever been solicited to participate in any form of corruption, and if so, how did you respond?





What sources do you rely on for information about EU integration and Ukraine's progress?






How would you assess your level of awareness regarding the preconditions for Ukraine to start formal negotiations on EU membership? - Aware






In your opinion, which of the following preconditions does Ukraine need to implement to start formal negotiations on EU membership? *Choose the ones you think are right*




How would you rate the effectiveness of Ukraine's central authorities' efforts to move towards EU membership?













Name the three most important issues for Ukraine that should be resolved after the war *(open-ended question)*




Weight of corruption in democratic governance cluster for national-level issues








Three most important issues for Ukraine: gender perspective




When do you think recovery should start?






In your opinion, who should be responsible for the implementation of recovery and reconstruction processes in Ukraine? (multiple choice question)





To what extent do you feel a sense of community in your current place of residence (your house, neigborhood, town)?





Generally speaking, compared to the period before the full-scale invasion, how would you rate your current level of trust towards fellow citizens?







Methodology: quantitative survey of Ukrainian population

Sample size National sample: 2,028 respondents; EDPs: 1,000 respondents. For analysis purposes, from the national sample 232 IDPs and 1,796 general population were disaggregated based on the displacement within the country as a result of the war.

Sample design National sample: interviews were conducted with Ukrainian citizens aged 18 years and older. Sample design corresponds to the distribution of the adult population of Ukraine by age, sex, oblast, and settlement type according to the data of the State Statistics Service of Ukraine as of January 1, 2019 (excluding Crimea and non-government-controlled areas of the Donetsk and Luhansk Oblasts)

EDPs: interviews were conducted with protection seekers from Ukraine aged 18 years old and older seeking in Poland, Germany, the Czech Republic, and Italy. The sample design corresponds to the distribution of refugees by country, according to the data provided by UNHCR.

MethodNational sample: CATI (computer-assisted telephone interviews);EDPs: SMS-CAWI: online interviews, links to the online questionnaire sent by SMS to potential
respondents randomly

Fieldwork dates March 2024

Margin of errorNational sample: margin of sample error (excluding the design effect) does not exceed 2.2%EDPs: margin of sample error (excluding the design effect) does not exceed 3.1%
